4. Matters Arising:

a. Towpath between Crooklands and Stainton (Bridget Pickthall)

Canals and Rivers Trust confirmed that they don't allow horse riding, but do allow you to lead your horse along the towpath.

Catherine Stott has opened a dialogue with them and Bridget has been collecting user evidence for this stretch so if you do ride this, please let Bridget know (chair@nlbs.org.uk). Northern reaches also aren't aware where the signs have appeared from.

5. Bridleway News

a. South Lakeland Parking – update (Hannah Gardner)

Hannah has been in correspondence with Westmorland and Furness council about parking with a trailer, which is not allowed in many car parks. Westmoreland and Furness Council are happy for equestrians to use their car parks on the following conditions:

If occupying two spaces, fees for both spaces need to be covered.

The trailer should remain attached to the vehicle at all times.

Be mindful of other car park users and as ever think through your own risk assessment.

In addition to the above please remember to take a shovel so you can clean up any dropping and hay. 'Leave no trace' as they say!

These car parks are really good for using the car ferry, Windermere to ride the fells in the Wray Castle area and riding Loughrigg Fell, Ambleside.

Suggested car parks to use are Ferry Nab (LA23 3JH) and Braithwaite Fold Car Park (LA23 3HB), Bowness-on-Windermere and Miller Bridge Car Park, Ambleside (LA22 0EE).

Many thanks to Hannah for pursuing this to such a positive conclusion. Hannah has also forwarded on to Catherine at BHS to publicise.

Bridget will send a letter of thanks on behalf of NLBS members to the council.

We expect now to see many photos on the NLBS Facebook page of members using the car park to access bridleways in the area and take the Ferry Challenge to access bridleways on the 'other side'

b. DMMO for bridleway in Over Kellet (see appended map)

Ailsa reported that another DMMO has been approved by the council and had an Order made, for a BW in Over Kellet, shown on the map below. This may be opposed by the landowner and so a final decision may not be made for some time.


